## Concrete Boom & Line Pump Hire - Terms & Conditions

- 1. All hires are made to the nearest hard road point or where the vehicle can get safely. The hirer shall be responsible for the ground upon which the pump is to traverse and set up on. This will be decided at the driver's discretion to proceed to destination or not.
- 2. A Safe System of work will be established this must be followed for each concrete pump hire under the Construction Plant-hire Association's Best Practice Guide for the Safe Use of Concrete Pumps, and in accordance with British Standard 8476:2007 or subsequent amendments.
- 3. Only our employees, no other person should operate such plant without the owner's prior written consent.
- 4. Our employees shall not operate any other plant or machinery or undertake work other than that for which they are supplied by the owner unless previously agreed in writing between the owner and the Hirer.
- 5. Threatening or abusive behaviour towards employees of Ve-Tech Concrete Limited will not be tolerated and the company reserves the right to terminate the hire and withdraw from the agreement.
- 6. Approx 60 minutes is required for the pump to be set up before it is ready to commence pumping and allow sufficient time after completed pumping to de-rig, wash out and prepare for travel. These periods of time will be charged at the working rate as agreed. Concrete should not be delivered to site until such time as pump operator deems that they are ready to commence pumping operations.
- 7. Our objective is to arrive on site when requested however all hire times are approximate. Ve-Tech Concrete Ltd will not accept liability for losses incurred by the customer due to late hire.
- 8. A competent person shall be present on site to sign for the hire of the pump operation.
- 9. This quotation is based on current costs of labour and fuel at the date of issue. Any increase in costs will be chargeable to the customer.
- 10. All prices quoted are subject to Value Added Tax, which will be added at the current rate, where applicable.
- 11. Non account customers are asked to pay within 24hrs of booking to secure a hire time.
- 12. Credit terms on account sales only are strictly 30 days from date of invoice.
- 13. Boom Pump Overtime charges will apply after an initial 10hrs on site. The hire will commence when the Pump arrives on site on or after the requested hire time.
- 14. Boom Pump Cancellation charges will be applied when hires are cancelled with less than 24hrs notice (out with weekends and public holidays). Cancellation fee of £435.
- 15. Line Pump Overtime charges will apply after an initial 5hrs (half day hire) or 10hrs (full day hire)- Including Boom pump hire at £1.66 per minute. The hire will commence when the Pump arrives on site on or after the requested hire time.
- 16. Line Pump Cancellation charges will be applied when hires are cancelled with less than 24hrs notice (out with weekends and public holidays) Half Day hire cancellation fee of £225 or Full day hire cancellation fee of £342.50.
